This will be a juried event of original art and fine handcrafts designed and produced by the artist working in acrylics, pastels, pencil, pen and ink, oils, watercolor, jewelry, photography, potter, sculpture, metals and mixed media. The event will be held at the Mimbres Valley Special Event Center, 2300 East Pine, Deming, N.M.

Eligibility Requirements

Artists are juried individually for their own work. If there is a collaboration to produce one product, please state so on the application. **No representatives** may sell for an artist and no items significantly dissimilar to juried items may be exhibited. Commercially manufactured, imported, kit or mass-produced items are not acceptable. Artist will be required to remove any item that Exhibition Committee deems inappropriate. Only artists who have been juried for jewelry may sell jewelry at the show. Individual artist may share a single booth with another artist with no more than a total of two different media. ALL ARTISTS and ALL MEDIA must be juried and accepted into the show. All accepted artworks must be for sale.

Application Procedures;

Artists send 3 photos with title of work and your name or CD containing 3 images representative of each medium being juried (300 dpi), artist names should not appear on the image. Please do not submit programs, photo albums, etc. on CD. Select photos or CD to represent your work of art that you are entering in the show, be sure to include two photos of each sculpture entry (front view and back view).

The name of the photo file should include your last name followed by the title of the artwork. For example, if your name is "Maria Rivera" and the title of your artwork is "Beautiful Artwork" the file name should be RiveraBeautifulArtwork.jpg. For sculpture it should be RiveraBeautifulArtwork1.jpg and RiveraBeautifulArtwork2.jpg to represent the front and back of the sculpture. **You can submit the application by email to the Deming Arts Council at demingarts@hotmail.com. All photos must be jpg.**

The Event Center will not allow anything to be nailed, pasted, or attached to the walls or ceilings.
NO red dyes, such as drinks, candles or punch.
NO glitter, duct tape on floor, chairs or walls, staples or hot glue.

Booth Spaces – are inside the Event Center. Booth spaces are 10x10. Carpeted or wood floor with electrical outlets at a minimum. Event Center does not provide pipe and drape. Wires cannot be taped to floor.

Volunteer Booth Sitter - There will be volunteer booth sitters to relieve the artist for lunch or short breaks.

Artists are required to provide their own free standing panel walls, grids, white canopies with no top, or other suitable booth enclosure or basic table set up. Nothing will be provided by the Deming Arts Council. Artists will be responsible for display pedestals, stands and cases, chairs. Tables must be covered, skirted to the floor and within allotted area.

Limited electric outlets – **Do you need electric?** _____

Two artists may share a booth space only upon acceptance of both artists by jury committee. Each artist must submit a separate application. Please make a copy of the application form and submit all forms together.

CD or photos must all be submitted together and postmarked by the deadline. You may submit to demingarts@hotmail.com.
