Booth Fee.....\$110

Booth Space is 10'x10 (No more than 2 artists per booth) Make checks, money orders, etc. payable to NWNMAC Exhibitors are responsible for Liability Insurance, and selling at their own booth. Artists may request a specific booth on their application. These requests will be assigned on a first-come, first served basis from the date their application is received by March 30, 2019. No refunds will be made for cancellations. Only sixteen booths will be available.

Booth Set Up

Friday, May 24, 2019.....7am to 3pm

The Fine Arts Tent will assist Riverfest in opening night VIP celebrations. Artists will have the opportunity to sell art in the Fine Arts Tent from 5pm to 9pm.

Booth Take Down

Sunday, May 26 2019..... 4pm

Artists are welcome to start taking down at 4pm. All booths must be out of the tent no later than 7pm. You are responsible for booth setup and take down.

*Fine Arts Exhibitors at Riverfest

(non-compliance will disqualify the exhibitor from participation)

All work exhibited must be original work created by the entrant. Signed, mechanical offset reproduction and/or giclee prints of the exhibitor's original artwork will be allowed but must be labeled as a reproduction. At least 80% of art displayed must be original art. The entrant must be juried into the show with their original artwork. Photo/photocopies of artwork will not be allowed. No posters will be allowed No commercial, manufactured or kit work including use of commercial molds, patterns, blanks, or dies will be allowed. No commercially manufactured mugs, T-shirts, caps, etc. are permitted. Commercially manufactured art tiles and coasters allowed only with original images of artist's work and be less than 10% of total work shown. Artists must have their own insurance to participate.

*Fine Art Exhibitors @ Riverfest Categories

(non-compliance will disqualify the exhibitor from participation)

Ceramics: Functional or decorative original clay and porcelain work other than jewelry. Machine made works from commercial molds and mass produced items are not permitted.

Digital Art: Work for which the original image, or the manipulation of other source material was executed by the artist using a computer. Signed and numbered editions on archival quality materials.

Drawings: Works in graphite, charcoal, colored pencil, chalk, wax crayon, pen and ink.

Fiber: Work crafted from fiber including clothing, basketry, weaving, quilting, leather work, paper-making. No machine screened patterns, mass production, or factory produced wearable items.

Glass (other than jewelry): Stained, hand blown, etched, slumped, fused, etc. No forms or mass production permitted.

Jewelry: Jewelry produced from silver, gold, platinum, non-precious metals, beads, clay, glass, fiber, wood, etc. No commercial casts, molds, or production work allowed.

Metal: Non-jewelry works crafted from metal including copper, wrought iron, brass, etc.

Mixed media: Any form of art which does not easily fit into other categories including gourd art.

Paintings: Works in oil, encaustic, acrylic, alkyd, casein, tempera, watercolor, pastels, and paintings under glass, mixed media.

Photography: Photographic prints made from the artist's original negative and processed by the artist or under the artist direction and printed on archival quality materials.

Printmaking: Hand printed, signed and numbered originals for which the artist hand manipulated the plates, stones or screens.

Sculpture: Three-dimensional original work done in any medium including bronze, wood, steel, ceramics, paper, etc.

Wood: Non-sculptural works in wood that are hand-tooled, machine worked, turned or carved including furniture, bowls, etc.
